The following information was gathered against the accused noted in the margin through sources into the allegation of acquisition of the assets disproportionate to their known sources of income.

A-1 Tr.P.Jayapal is now working as Deputy Director, Geology and Mining, Krishnagiri formerly Deputy Director, Geology and Mining, Karur, i/c Perampalur District. He is a public servant

as defined u/s 2(c) of the Prevention of Corruption Act, 1988. A-2 Tmt.Anuradha is the wife of A-1 Tr.P.Jayapal. She is a private individual.

A-1 Tr.P.Jayapal hails from a middle-class family. He is a native of Periya Sathapatty Village, Samrajpet via, Mettur Taluk, Salem District. A-1 and A-2 were blessed with two kids. Their son J.Sukanthan is studying 11th standard and daughter Selvi.J.Srinithi is studying 8th standard in Sri Vidhya Mandhir School, Steel Plant, Salem. A-2 Tmt.Anuradha is an income tax assessee. The general reputation of A-1 is learnt to be not good.

A-1 Tr.P.Jayapal amassed wealth in his name and in the name of his wife A-2 Tmt.Anuradha during the period of his office. Most of the acquisitive activities of A-1 fall between 01.04.2016 and 31.03.2022 hence, it was chosen as the tentative check period. A-1 and his wife were found in possession of assets as detailed below.

The available information makes out a prima facie case against A-1 Tr.P.Jayapal and his wife A-2 Tmt.Anuradha that they were in possession of pecuniary resources and properties and enriched themselves illicitly to the tune of Rs.95,03,919/- which comes 106 % of their total income during the check period, which is disproportionate to their known sources of income. Thereby, A-1 Tr.P.Jayapal had committed the offence of Criminal Misconduct and his wife A-2 Tmt.Anuradha had abetted him to commit the said offence by holding a substantial portion of the assets on behalf of A-1.

Therefore, today 18.12.2024 at 15.00 hrs, I registered a case in Dharmapuri Vigilance and Anti-Corruption Cr.No.08/AC/2024 against A-1 Tr.P.Jayapal for the commission of the offence punishable u/s 13(2) r/w 13(1)(e) of the Prevention of Corruption Act, 1988 for the period from 01.04.2016 to 25.07.2018 and 13(2) r/w 13(1)(b) of the Prevention of Corruption Act, 1988 as amended in 2018 for the period from 26.07.2018 to 31.03.2022 and A-2 Tmt.Anuradha abetted the above said commission of the offence, punishable u/s 109 IPC r/w 13(2) r/w 13(1)(e) of the Prevention of Corruption Act, 1988 for the period from 01.04.2016 to 25.07.2018 and u/s 12 r/w 13(2) r/w 13(1)(b) of the Prevention of Corruption Act, 1988 as amended in 2018 for the period from 26.07.2018 to 31.03.2022.

The original F.I.R is submitted to the Hon'ble court of the Special Judge/Chief Judicial Magistrate, Dharmapuri District and a copy of the FIR is sent to the Superintendent of Police, Vigilance and Anti-Corruption, Western Range for issuing authorization u/s 17 and 18 of the Prevention of Corruption Act, 1988 to Tr.N.Narendran, Inspector of Police, Vigilance and Anti-Corruption, Salem to take up investigation in the case.
