The Preliminary Enquiry report submitted by an officer of Vigilance and Anti-Corruption, Tiruvannamalai detachment revealed the following information:-

On the petition sent by Dr.M.K.Vishnu S/o.M.Krishnasamy, Member of Parliament, Arani Parliamentary Constituency, Tiruvannamalai District to the President, the Tamil Nadu Lokayukta, Chennai in connection with the irregularities and mal practices committed in implementing Pradhan Mantri AwaasYojana free housing scheme in Tiruvannamalai District during the year 2017-2018 in Vandavasi Block and Jawadhu Hills Block and during the period 2019-2020 in Thellar Block in Tiruvannamalai District. In accordance with the order of the Hon'ble the Tamil Nadu Lokavukta at Chennai and the order of the Director of Vigilance and Anti-Corruption, a Preliminary Enquiry vide No. PE-92/2020/RDP/TVM was registered on 14.12.2020 and on that core, the prima facie case ascertained that the mal practices and irregularities were committed in implementing the PMAY-G in the aforesaid block.

The Accused No.1 Tr.Kuppusamy was serving as Block Development Officer at Vandavasi Block... name and address (A1 to A24).... Thereby, A1 to A24 are public servants under the definition of 2(c) of the Prevention of Corruption Act, 1988.

PMAY-G aims to provide pucca houses with basic amenities to all eligible houseless households and households living in kutcha and dilapidated house in rural areas. To achieve the objective of "Housing for All" PMAY-G envisages construction of quality houses by the beneficiaries themselves using locally available construction materials, using

In the implementation of the PMAY-G Scheme, the beneficiaries have to be identified and procedure of selection will be based on the housing deficiency and other social deprivation parameters in SECC – 2011 (Socio Economic Caste Census) data and verified by the Gram Sabhas. The Assistant Engineer has to undertake the field inspection and send his report to the authorities and recommend to sanction the fund under PMAY Gramin Scheme.

During the year 2017-18, PMAY scheme was implemented in all the 61 Village Panchayats of Vandavasi Panchayat Union, Tiruvannamalai District. A house under the above scheme was allotted to Tmt.Amsa, W/o.Veliyappan (ID No: TN-2169275), Ozhappakkam Village, Vandavasi Panchayat Union. The beneficiary Tmt. Amsa poor widow and her husband Tr.R.Veliyappan and her son Rajesh were died in a road accident. She has no agricultural land but jointly owned a house site to the extent of 434 sq.ft. with her brother-in-law as such she is an eligible beneficiary to avail the house under the PMAY-Gramin Scheme.

Tmt.Amsa, After selecting W/o.Veliyappan as beneficiary on the basis of Socio Economic Caste Census data by the Gram Sabha, the A1, A4, A7, A11, A16 and public A20. being the servants authorities for collecting documents of the beneficiary, verification, inspection, recommendation, issuing work order and disbursement of the material cost etc., they hatched a criminal conspiracy to issue the work order to the ineligible beneficiary with a motive to derive the pecuniary advantage.

After hatching the criminal conspiracy, the A20 and A11 are Panchayat Secretary Zonal Deputy **BDO** and (Zone-III) respectively, are the authorities to collect the documentsfrom the beneficiary Tmt.Amsa, W/o.Veliyappan and its verification, they purposively neglected the eligible beneficiary Tmt.Amsa, W/o.Veliyappan and with an oblique motive, they collected the Family Card, Aadhaar Card, Bank Account Pass Book, Voter ID, etc from the ineligible Tmt.Amsa, W/o.Arulmozhi, beneficiary Kosappattu Village in Ozhappakkam Village Panchayat and recommended her for getting free house under PMAY-Gramin Scheme, A4 9. A7 Tr,M.Ramu being Assistant Engineer of Vandavasi Block had undertook field inspection and prepared based on the false documents and forwarded them as if it was belonged to the selected beneficiary and allowed the undeserved person, who was not listed in the SECC-2011 and recommended to sanction the fund under PMAY-Gramin Scheme instead of selected beneficiary. The fund of Rs.1,20,000/- was sanctioned to the ineligible beneficiary Tmt.Amsa, W/o.Arul @ Arulmozhi in 4 installments. Thereby, A1, A4, A7, A11, A16 and A20 caused a wrongful loss to the Government to the tune of Rs.1,70,000/including the material cost during the year 2017-2018.

During the year 2017-18, the beneficiaries Tr.K.Govindan, **PMAY** ID No.2344812 and Tmt.Ranganayagi, PMAY ID No.2339372 of Keezh Narama Village in Vandavasi selected Taluk were beneficiaries as per SECC data.

Tmt.Malliga (TN 1407750) was selected under PMAY-Gramin as per SECC-2011 data during the year 2019-2020. A22 Tr.S.Ramajeyam being the Panchayat Secretary Chittragavul of A5 Tr.Ravichadran being the Villageand Deputy BDO had collected and furnished the required documents including Bank Account No. and Pass Book from the ineligible beneficiaryTmt. Mallika, W/o Suburayan instead of eligible beneficiary Tmt. Mallika Subramani. She submitted collected documents and verification report to A2 Tr.Bharanidharan being the BDO of Thellar Block, Tiruvannamalai district for sanctioning work order. The BDO Thellar had issued work order without verifying the documents furnished by the Panchayat Secretary and Zonal Dy. BDO. The fund was transferred toTmt.Mallika, W/o Suburayan who was an ineligible person. The selected beneficiary was not received the fund from the Government for the construction house under the Scheme.

BDO and issued work irregular orders in an A17 Tr. C.Sakthivel being the union Overseer had not verified the genuineness of the beneficiaries as listed in Socio Economic Caste Census-2011 (SECC-2011) and per the work orders issued by the Block Development Officer while supervising the construction of works at the site and submitted the work completion report about the wrong site stage by stage and A8 Tr.A.Kesavan Assistant Engineer, Formerly at Thellar Block, Now at Thandarampattu Block had undertook field inspection and prepared bills based on the false documents and forwarded them as it belongs to selected beneficiaries and allowed the ineligible and undeserved person W/o.Subburayan, C.M.Pudur, Chittragavur Village, Madura of Thellar Block who is not

listed in Socio Economic Caste Census-2011 (SECC-2011) and recommended to sanction the fund under PMAY-Gramin Scheme instead of selected beneficiary Tmt. Mallika, W/o Subramani, Chitragavour Village during the year 2019-2020 thereby caused loss to the Government to the tune of Rs.1,70,000/-including the material cost.

During the year 2017-2018, PMAY Scheme was implemented in all the 11 Village Panchayats of Jawadhu Hills Panchayat Union in Tiruvannamalai District. W/o. Periyapaiyan (TN1173762), D/o Ramasamv. 2. Tmt. W/o Rajan, 2. Tmt. Seettai (TN 1273474), W/o (TN 1273474), Rajan, Kallipparai Hamlet Village in VeerappanurVillage Panchayat3.Tr. S. Sivakumar, (TN1612941), S/o Shanmugam, Veerappanur Village and 4.Tmt. VeerappanurVillage were selected as a Neela, (TN1600675) W/o Hari. beneficiary under PMAY-Gramin scheme during the year 2017-2018 in Veerappanur Village Panchayat of Jawadhu Hills Panchayat Union. The work orders were issued to 1. Tr. Govindan, S/o Vellaiyan, Arasavalli Hamlet, 2. Tmt. Settai Govindan, Kollakkottai Hamlet, 3. Tr. Sivaskumar, S/o Pappan Karaiyan and 4. Tmt. Neela, W/o Kuselan instead of selected beneficiaries Tmt. KuppuPeriyapaiyan, D/o Ramasamy and Tmt. Seettai, W/o Rajan, Kallipparai Hamlet Village, 3. Tmt. Neela Hari, Veerappanur Village and 4. Tr.S. Sivakumar, S/o Shanmugam, Veerappanur Village The first installment of Rs.26,000/- only

has been credited to the account no. of Govindan S/o Vellaiyan and he had been said to be died. The entire installments were given to wrong beneficiaries and credited in to their account numbers.

A23 Tr. M. Ponnusamy, Panchayat Secretary Nammiyampattu, full additional Charge of Veerappanur Village Panchayat and A14 Tr.P.Radhakrishnan, Zonal Dy. BDO, formerly at Jawadhu Hills Block, Now Dy. BDO, (Noon Meal Programme), Jawadhu Hills Blockhad identified and verified the genuineness of the beneficiaries and recommended as per name mentioned in the SECC-2011 as 1. Tmt. KuppuPeriyapaiyan, D/o Ramasamy data 2. Tmt. Settai Rajan 3. Tmt. Neela Hari, Veerappanur Village and 4.Tr. S. Sivakumar, S/o Shanmugam, Veerappanur Village, but they intentionally collected and furnished required documents including Bank Account nos. and land documents etc., from Tr.V.Govindan, S/o Vellaiyan, Arasavalli Village, Veerappanur Village, Jamunamarathur Taluk, 2. Tmt. Seetai Govindan, Kollakottai Hamlet Village, 3.Tmt. Neela, W/o Kuselan, Veerappanur Village and 4.Tr. Sivakumar, W/o Pappan Karaiyan, Veerappanur Village respectively.

A6 Tr.Anbalagan, Deputy Block Development Officer (Panchayats), formerly at Jawadhu Hills Block Now at Kalasapakkam Block and Tr.L.Seenivasan Block Development Officer, Formerly at Jawadhu Hills Now at Arni Block had not verified the genuineness of the beneficiaries as per SECC data with the documents furnished by the Panchayat Secretary and Zonal Deputy Block Development Officer. The work orders were issued by A3 Tr.L.Seenuvasan, formerly Block Development OfficerJawadhu Hills to the wrong beneficiaries instead of selected beneficiaries in an irregular manner.

A18 Tr.M.Anandakumar, Union Overseer, formerly at Jawadhu Hills Block had not verified the genuineness of the beneficiaries as listed in Socio Economic Caste Census-2011 (SECC-2011) and per the work orders issued by the Block Development Officer while supervising the construction of works at the site and submitted the work completion report about the wrong site stage by stage and A9 Tr.R.Tamilselvan, Assistant Engineer, Jawadhu Hills Block had undertook field inspection and prepared bills based on the false documents and forwarded them as it belongs to selected beneficiaries and allowed the undeserved the persons who were not listed in Socio Economic Caste Census-2011 (SECC-2011) and recommended to sanction the fund under PMAY-Gramin Scheme instead of selected beneficiaries during the year 2017-2018, thereby caused loss to the Government to the total amount of Rs.5,36,000/- including the material costs.

Tr.L.Govindaraj, age 52/2021, S/o Lakshmanan, Palamarathur Village & Post, Jamunamarathur Taluk, Tiruvannamalai District has been living with his wife, 3 sons and one daughter and possesses 2 acres of agriculture land in that Village. During the year 2017-2018 he was allotted to construct house under PMAY-Gramin scheme. His work order was given to Tr.K.Govindaraj, S/o Krishnan in Palamarathur Village.

No fund was sanctioned to him for the construction of house. His work order was misused by the officials of Jawadhu Hills Block and obtained documents from Tr.K.Govindaraj, S/o Krishnan and the entire amount was given to him for the construction of house in an irregular manner.

Tr. L. Govindaraj, PMAY ID No. TN1979560, S/o Lakshmanan, Palamarathur Village was selected as beneficiary as per SECC-data. But A24 Tr.A.Umapathy Panchayat Secretary of Palamarathur Village Panchayat and A15 Tr. M. Rajendiran, Zonal Dy. BDO formerly at Jawadhu Hills Now MGNREGS, Jawadhu Hills Block had identified and verified the beneficiary as per name mentioned in the SECC-2011 data but they intentionally collected and furnished required documents including Bank Account nos. and land documents etc from Tr.K.Govindaraj, S/o Krishnan, Palamarathur Village, Jamunamarathur Taluk, who was not the beneficiary as per SECC data and recommended a wrong beneficiary.

A6 Tr.R.Anbalagan Deputy Block Development Officer (Panchayats) formerly at Jawadhu Hills BlockNow at Kalasapakkam Block and A3 Tr.L.SeenuvasanBlock Development Officer, Formerly at Jawadhu Hills Now at Arni Block had not verified the genuineness of the documents furnished by the Panchayat Secretary and Zonal DeputyBlock Development Officer with SECC-2011 data and issued work orders in an irregular manner.

A19 Tr.C.Veerapathiran, Union Overseer, formerly at Jawadhu Hills Thellar Block, Now Pudupalayam Block had not verified the genuineness of the beneficiaries as listed in Socio Economic Caste Census-2011 (SECC-2011) and per the work orders issued by the Block Development Officer while supervising the construction of works at the site and submitted the work completion report stage by stage and A10, Tr.M.Nirmalraj, Assistant Engineer, Formerly at Jawadhu Hills Block had undertook field inspection and prepared forged bills based on the false documents and forwarded them as if it were belongs to selected beneficiaries and allowed the ineligible / undeserved persons who were not listed in Socio Economic Caste Census-2011 (SECC-2011) and recommended to sanction the fund under PMAY-Gramin Scheme instead of

selected beneficiary during the year 2017-2018, thereby caused loss to the Government to the tune of Rs.1,70,000/- including the material cost.

Hence, the prima facie case under section 120B, 167, 420, 468, 471 and 477A IPC and under section 13(2) r/w 13(1)(c) of the PC Act, 1988 is made out against the Accused No.1 to Accused No.24 for the offences of criminal conspiracy, framed incorrect statements in the official records and cheated the public funds in favour of the ineligible beneficiaries and cheating are made out in the execution of scheme to the beneficiaries Tmt.Amsa, W/o.Veliyappan, Tr.K.Govindan. Tmt.Ranganayagi, Tmt.Kuppu W/o.Periyapaiyan, and Tr.L.Govindaraj, S/o.Lakshmanan during the period of 2017-2018. Similarly, the prima facie case is made out for the cognizable offences under section 120B, 167, 420, 468, 471 and 477A IPC and section 13(2) r/w 13(1)(a) of the Prevention of Corruption Act, 1988 as amended by the Prevention of Corruption (Amendment) Act, 2018 for the offence committed during the year 2019-2020 in the allotment of house for the beneficiaries Tmt.Mallika W/o.Subramani, Tr.K.Babu, S/o.Moorthy, Tmt.Kaniyammal w/o.Elumalai, Tmt.Seetai w/o.Rajan, Tr.Sivakumar S/o.Shanmugam, and Tmt.Neela W/o.Hari.

Hence, I am registering a case in Tiruvannamalai Vigilance and Anti-Corruption, Crime.No.08/2024 u/s 120(B), 167, 420, 468, 471 and 477A IPC and 13(2) r/w 13(1) (c) of the PC Act 1988 for the period during 2017-2018 and 120(B), 167, 420, 468, 471 and 477A IPC and 13(2) r/w 13(1) (a) of the PC Act 1988 as amended by the Prevention of Corruption (Amendment) Act, 2018 for the period during 2019-2020 against A1 to A24 on 24.06.2024 at 20.00 Hrs.

The original FIR was submitted to the Hon'ble Special Judge cum Chief Judicial Magistrate, Tiruvannamalai and other copies were sent to the officers concerned.
