Sir, Received the Information pertaining to the Registration of FIR today (03.10.2024) at 11.30hrs, as per the instruction of Directorate of Vigilance and Anti-Corruption, Chennai vide memorandum No.PE.50/2023/RDP/VN, Dated:12.09.2024 registered the case in Virudhunagar, Vigilance and Anti – Corruption Cr.No.11/2024 w/s 7 of the Prevention of Corruption Act-1988 as amended in 2018. Based on the Vigilance report No.03/2022-2023 sent to the Directorate of Vigilance and Anti – Corruption, Chennai by the Inspector of Police, Vigilance and Anti-Corruption, Virudhunagar Detachment, the Vigilance Report No.VRF No.87/2022/35121/SW/VN dated:25.01.2023 of the Directorate of Vigilance and Anti-Corruption, Chennai has been sent to the Vigilance Commissioner and permission has been obtained through G.O (3D) No.19 dated:05/06/2023 of the Principal Secretary of Tamil Nadu Rural Development and Panchayat Raj Department to conduct Preliminary Enquiry against the accused person. The Preliminary Enquiry was registered on 12/07/2023 in

<u>Virudhunagar Vigilance and Anti-Corruption Cr.No.11/2024 u/s 7 of the Prevention of Corruption Act 1988 as amended in 2018 FIR Continuation.</u>

Vigilance and Anti – Corruption, Virudhunagar District as per the memorandum No.PE.50/2023/RDP/VN, dated:04/07/2023 of the Directorate of Vigilance and Anti - Corruption, Chennai. The Preliminary Enquiry Report revealed the following facts.

One Tmt.Velammal belongs to Valayapatti Village, Elluppaiyor was working as a cook in Elluppaiyor NKV Sala Primary School, and died due to ill health on 06/07/2021 while working.

After that as per the instruction of one Tr.Malaisamy the Secretary of Narikudi, Satunavu Employees Union, who worked as a nutritionist in Elluppaiyor Government High School, Tmt.Seeniammal with the help of her brother Pambulu prepared a petition requesting her mother's job as a cook on compassionate grounds and attached the necessary documents and filed a petition to the Block Development Officer, Narikudi Panchayat Union in the second week of September 2021 and also said that she has been working as a cooking assistant in Amman Patti Panchayat Union Middle School since march month of 2023 ie 06/03/2023 onwards.

On 08/08/2022 at 2.00 p.m. Tr.Selvaraj working as Personal Assistant of the District Collector of Virudhunagar came to Narikudi Panchayat Union Office for an Annual visit that, he asked for the file related to job as a cook on Compassionate ground and perused the file related to Tmt.Seeniammal application and he asked for the applicant's Mobile number. Accordingly one Tr.Sathishkumar, Computer Operator, Narikudi Panchayat Union office had given the Mobile number 63791-54055 of Pambulu the applicant's brother to Tr.Selvaraj.

Further on 09/08/2022 when Pambulu was in the Village of Kullampatti at about 08.00 a.m, a person spoke to him on his mobile Phone No.63791-54055 that, he was speaking from the District Collector Office and said that, he has a file related to job on compassionate ground of his sister Tmt.Seeniammal and he will take action on it and contact about it later.

Again on 09/08/2022 at 08.00 p.m the same person contacted to him or his above said Mobile Phone number that, the job available to his sister Tmt.Seeniyammal is a permanent Government job therefore, to be granted that permanent order prepare Rs.15,000/- and come to Aruppukottai tomorrow morning at 08.00 a.m.

Further as per the instruction of Tr.Selvaraj, his Assistant Tr.Vinoth had prepared an office note on the application of Tmt.Seeniammal for the appointment as a cook on compassionate ground on 11/08/2022 and put on Tr.Selvaraj's desk for approval of District Collector.

The said Pambulu had recorded the conversation made between him and the accused officer Tr.Selvaraj regarding the demanded Rs.15,000/- as undue advantage from the said Pambulu in relation to providing a Compassionate ground appointment order to Tmt.Seeniammal in his mobile phone and sent it to Tr.Malaisamy and that Tr.Malaisamy had sent the cell phone conversation to Tr.Subbukalai the treasurer of Virudunagar District Satunavu Employees Union, through WhatsApp message. Further Tr.Subbukalai had circulated it in a social media and also identified the voice recording of Tr.Selvaraj in the CD to the Police.

The above information collected during enquiry, disclose that prima facie evidence are available for offence u/s 7 of the Prevention of Corruption Act-1988 as amended in 2018.

Prior permission which was accorded vide government letter G.O (3D) No.11, Dated:16.05.2024 of the Principal Secretary of Tamil Nadu, Rural Development and Panchayat Raj Department under section 17(A) of the Prevention of Corruption Act-1988 as amended in 2018 to register a regular case against the above said accused person Tr.Selvaraj, Formerly Personal Assistant to District Collector (Noon Meal), Virudhunagar District is also enclosed here with.

Hence I am registering a case in Vigilance and Anti – Corruption, Virudhunagar Cr.No.11/2024 u/s 7 of the Prevention of Corruption Act-1988 as amended in 2018 against the accused person Tr.Selvaraj vide Directorate of Vigilance and Anti – Corruption memorandum PE.50/2023/RDP/VN, Dated.12.09.2024.
