AO-1 Tr.Perumal, Age 52 S/o.Muniyappan, Formerly Panchayat Secretary, Arappedu Village, Chithamur Panchayat Union, Cheyyur Taluk, Chengalpattu District. Now Panchayat Secretary, Puliyani Village, Chithamur Panchayat Union, Chengalpattu District. Group "D" A-2 Tmt. Ellammal Aged about 42/2023, W/o.Perumal No.6, Theradi Street, Kolathur Post, Cheyyur Taluk, Chengalpattu District. (Private Individual)



DVAC, The Director, Chennai ordered to conduct preliminary enquiry PE PT 8516/2021/RDP/KM, PE in 45/2023/RDP/KM dated 21.06.2023 against the complaint of on Tr.M.Munusamy, S/o.Mannar Naidu, Mariamman Koil Street, No.22 Arapedu Village, dated 26.07.2021. Accordingly Preliminary Enquiry was registered on 19.07.2023 and enquiry was conducted Tr.S.Saravanan, Deputy by Police, V&AC, Superintendent of Chengalpattu Detachment.

In the compliant, it is alleged that 1) The counter petitioner/Suspect Officer Tr.M.Perumal, is working as Panchayat Secretary at the office of the Arapedu Panchayat Office for 25 years and committed various irregularities. Hence the complainant Tr.Munusamy sent a complaint dated 31.08.2020 to the Block Development Officer for transferring him and no action was taken.

2) Without construction of lavatory under the scheme of Swatch Bharat Mission, a sum of Rs.12,000/- credited in to the account of suspect officer's wife viz. Tmt.Ellammal W/o.Perumal, 3) A sum of Rs.1,70,000/- credited into the account of suspect officer's mother in law viz. Tmt.Subbammal W/o.Subburayan without construction of Group House during the year 2019 and 2020, 4) A sum of Rs.1,00,000/- was credited into the account of suspect officer's sister in law viz. Tmt.Yasodha W/o.Subramani under the scheme of Group House during the year 2011 and 2012. As like suspect officer's brother Tr.Subbramani S/o.Desappan received a sum of Rs.1,00,000/- during the year 2012 and 2013. In the same scheme, both husband and wife were benefited and 5) Members of the family of Suspect Officer received wages without doing work under the scheme of MGNREGS (Mahatma Gandhi National Rural Employment Guarantee Scheme).

During Preliminary Enquiry it is ascertained that Tr.M.Perumal S/o Muniyappan, recruited as part time writer at Arappedu Panchayat on 13.08.1997. Subsequently enlisted as Panchayat Secretary on 09.07.2013, as per G.O.(Ms.) No.72, Rural Development & Panchayat Raj (E5) Department Dated:09.07.2013. He was transferred to Ammanambakkam Panchayat on administrative grounds on 06.08.2021. Subsequently he was transferred to Arappedu Panchayat on 05.05.2022. Again he was transferred to Puliyani Panchayat on administrative grounds on 31.03.2023. Now he is working as Panchayat Secretary at Puliyani Panchayat from 31.03.2023. The petitioner addressed petition dated 31.08.2020 to the Block Development Officer and it is not available in the BDO office.

Tr.M.Perumal S/o Muniyappan, Panchayat Secretary is a public servant during the alleged period as defined in section 2(c) of the Prevention of Corruption Act 1988 (as amended in 2018).

Enquiry ascertained that the Panchayat Secretary/AO Tr.Perumal included his wife name as beneficiary of Swatch Bharat Mission (G) during the year 2013 and thereby A-2 Ellammal W/o. Perumal listed as a beneficiary in SBM(G) scheme. On 05.08.2016 AO Tr.Perumal forged the signature of the then President, Arappedu Panchayat viz. Tr.A.S.Rajagopal and thereby issued work order as given by Tr.A.S.Rajagopal to A-2 Ellammal W/o.Perumal for construction of individual household latrine under SBM(G) scheme and the same was presented to the BDO, Chithamur. According to the said work order dated 05.08.2016, the AO wife did not construct individual household latrine under SBM(G) scheme and the same was completed on 20.02.2020. A sum of Rs.3774/- and Rs.8,226/- was sanctioned as first instalment and second instalment respectively by the Block Development Officer Tr.Nirmalan (Died during Corona period) on 19.03.2020. Cheque of Rs.12,000/- was issued to A-2

Tmt.Ellammal W/o Perumal on 31.03.2020. And the same was credited into the bank account of A-2 Tmt.Ellammal W/o.Perumal on 07.04.2020.

As per guidelines of Swatch Bharath Mission (G), A-2 Tmt.Ellammal is not eligible to construct individual household latrine under SBM(G) scheme. However her name was included by suppressing the fact as the AO-1's wife A-2 is not eligible in the said scheme and thereby cheated the authorities concerned by furnishing certificate that his wife is in the list of beneficiary in SBM(G) scheme. AO-1 is also forged the signature of the then President, Arappedu Panchayat Tr.A.S.Rajagopal and issued forged work order for construction of individual household latrine to his wife as given by Tr.A.S.Rajagopal and the same was used as genuine. And thereby misappropriated an amount of Rs.12,000/-

Enquiry also ascertained that A-2 Ellammal W/o.Perumal included one of the beneficiary in Mahatma Gandhi National Rural employment Guarantee Scheme by AO-1 Tr.Perumal on 06.08.2008. During that time AO-1 worked as a part time writer in Arappedu Panchayat and enlisted as Secretary of Arappedu Panchayat on 09.07.2013. AO-1 could not stop the beneficiary of his wife A-2 in the said scheme. Therefore on the dates of 09.07.2013 to 11.01.2024, A-2 received an amount of Rs.1,61,594/- in this scheme and misappropriated the above said amount and thereby caused wrong full loss to Government.

The aforesaid act constitute an offences punishable under section 13(1)(c) r/w 13(2) of PC Act, 1988 and 420, 465, 467, 468, 471 IPC, 109 IPC r/w 13(1)(c) r/w 13(2) of Prevention of Corruption Act-1988, and 13(1) (a) r/w 13(2) Prevention of Corruption (Amendment) Act,2018 and 12 r/w 13(1)(a) r/w 13(2) of PC (Amended) Act, 2018.

The Director, Vigilance and Anti-Corruption ordered to register a regular case in DVAC memorandum No.PE 45/2023/RDP/KM dated 05.12.2024 against AO-1 Tr.Perumal, Formerly Panchayat Secretary, Arappedu Village, Chithamur Panchayat Union, Cheyyur Taluk, Chengalpattu District. Now Panchayat Secretary, Puliyani Village, Chithamur Panchayat Union, Chengalpattu District and A-2 Tmt.Ellammal W/o. Perumal after obtaining permission u/s 17A of Prevention of Corruption (Amendment) Act, 2018. As per memorandum in PE.No.45/2023/RDP/KM, dated. 23.01.2025 of the Director DVAC, Chennai (received on 29.01.2025) and upon perusal of documents, I registered a regular case against the accused mentioned in column 7 and 12 of FIR today on 29.01.2025 at 18.00 Hrs.

The Original FIR is herewith submitted before the Hon'ble Court of Chief Judicial Magistrate cum Special Judge, Chengalpattu and a Copy of FIR is sent to DVAC Headquarters for information and record. Further, I am transferring this case investigation to Tr.G.Annadurai, Inspector of Police, V&AC, Chengalpattu Detachment, as per orders of the Director, Vigilance and Anti-Corruption in PE.No.45/2023/RDP/KM, Dated 23.01.2025.
