## Accused

1.Tr.M.Muthusamy, 51/25, S/o P.Muthusamy Formerly Thasildar, Oddanchatram Taluk, Dindigul District now Personal Assistant to the Revenue Divisional Officer, Palani Division, Dindigul District

2.Tmt.V.Sathya, age 45/2025, W/o.M.Muthusamy, Computer Instructor Grade-I, Kasthuri Reddiyar Model Government Higher Secondary School, Oddanchatram, Dindigul District. The information of accumulation of assets disproportionately by the marginally noted Accused-1 Tr.M.Muthusamy in his name and in the name of his wife Accused-2 Tmt.V.Sathya during the check period 01.04.2019 and 31.03.2023 was gathered during the collection of information against the accused.

The Accused-1 Tr.M.Muthusamy was employed as Thasildar, Oddanchatram Taluk, Dindigul District from 09.07.2021 to 21.02.2024 and prior to that, he worked as Thasildar (SSS), Vedasandur Taluk and Special Thasildar (Stamps), Palani, Dindigul District during the period of commission of offence.

The Accused-2 Tmt.V.Sathya is working as Computer Instructor Grade-I in Kasthuri Reddiyar Government Model Higher Secondary School, Oddanchatram, Dindigul District from 27.09.2017.

The accused-1 Tr.M.Muthusamy and his wife A-2 Tmt.V.Sathya are public servants as defined u/s 2(c) of the Prevention of Corruption (Amendment) Act 2018 during the period of commission of offence.

Accused-1 Tr.M.Muthusamy is a native of Virupatchi Village, Oddanchatram Taluk, Dindigul District and he hails from a middle class family. He had joined in the Government service as Assistant in Revenue Department, Dindigul District on 17.09.2001 and promoted as Thasildar and posted to Oddanchatram Taluk, Dindigul District and served from 09.07.2021 to



21.02.2024 as regular Thasildar. Normally the period of regular Thasildar is one year whereas Accused-1 served as regular Thasildar for the period of 3 years. Now he is working as Personal Assistant to the Revenue Divisional Officer, Palani Division, Dindigul District from 21.02.2024.

Accused-1 Tr.M.Muthusamy married Accused-2 Tmt.V.Sathya in 2004 and she is working as Computer Instructor in Kasthuri Reddiyar Government Model Higher Secondary School, Oddanchatram, Dindigul District.

It is gathered that Accused-1 Tr.M.Muthusamy intentionally enriches himself illicitly in his name and in the name of his wife Accused-2 Tmt.V.Sathya during the period of his public service in various places. Most of the acquisitive activities of A-1 and his wife falls between 01.04.2019 and 31.03.2023 and hence it was chosen as tentative check period and during that period A-1 and his wife were found in possession of assets as detailed below.

The available information makes out a prima facic case against Accused-1 Tr.M.Muthusamy and his wife Accused-2 Tmt.V.Sathya that they were in possession of pecuniary resources and properties to the tune of Rs.1,01,99,499/- which comes @ 68.92% during the check period, which is disproportionate to their known sources of income. Thereby, A-1 had committed the offence of criminal misconduct by intentionally enriching himself illicitly during the period of his office and his wife A-2 Tmt.V.Sathya had abetted him to commit the said offence by acquiring the assets through the resources of A-1.

Therefore, today 30.01.2025 at 18.00 hrs, I registered a case in Dindigul Vigilance and Anti-Corruption Cr.No.01/2025 against Accused-1 Tr.M.Muthusamy, u/s 120B IPC and 13(2) r/w 13(1) (b) of Prevention of Corruption Act 1988 as amended in 2018 and Accused-2 Tmt.V.Sathya, u/s120B IPC, 12 r/w 13(2) r/w (1) (b) of the Prevention of Corruption Act 1988 as amended in 2018.

The original F.I.R is submitted to the Hon'ble court of the Special Judge/Chief Judicial Magistrate, Dindigul District and a copy of the FIR is sent to the Superintendent of Police, Vigilance and Anti-Corruption, Southern Range issuing order u/s 17 of the Prevention of Corruption (Amendment) Act 2018 to investigate the case and authorization u/s 18 of the said Act to inspect bankers books in relation to the accounts of A-1 and his family members.
