Tr.A.Balaji. Field Surveyor, formerly of Tiruvannamalai District, on deputation at Ambur Taluk, Tirupathur District (u/s). The accused Tr.A.Balaji is a Public Servant within the meaning of section 2 (c) of the Prevention of Corruption Act, 1988. The accused entered into Government service on

on 01.06.2020 as Field Surveyor. He underwent 60 days of survey training from 01.06.2020 to 02.08.2020. Thereafter, he has worked at (Arani Mobile) Arani Taluk from 03.08.2020 to 22.09.2020. Further, he underwent 30 days of practical training from 23.09.2020 to 22.10.2020. Then, he worked at Vellore District OPT (Online Patta Transfer) on deputation work from 23.10.2020 to 11.11.2020. Then, from 12.11.2020 to 22.09.2021 he worked at (Arani Mobile) Arani Taluk. From 23.09.2021, he has worked at Thirupathur District on deputation work. Now the accused is under suspension with effect from 29.01.2022, pursuant to his arrest in a trap case, vide Vellore V&AC Crime No.1/2022 u/s 7 (a) of the Prevention of Corruption Act, 1988 (as amended by the Prevention of Corruption (Amendment) Act, 2018).

The accused is a native of Shenbakkam Village of Vellore Taluk in Vellore District. His father Tr.P.Arumugam worked as Head Draughtsman at Thiruvannamali District and died on 20.03.2017 due to heart attack while in service. His mother Tmt.A.Bakkiyam is a homemaker and she is receiving a family pension after the death of her husband. He has 2 younger brothers and both were married before 01.06.2020. The accused married Tmt.Sangeetha on 03.02.2023 and his wife is working as a Nurse in a private hospital. The accused and his brothers are residing with their mother as a joint family at No.28/27, Kzhanikaattu Street, Shenbakkam, Vellore.

On 29.01.2022, the accused was trapped and arrested for demand and acceptance of bribe of Rs.8,000/- from the complainant in Vellore V&AC Crime No.1/2022. During the search conducted on 29.01.2022 at the residence of the

accused Tr.A.Balaji at No.28/27, Kzhanikaattu' Street, Shenbakkam, Vellore, unaccounted cash of Rs.22,34,650/- has been seized from the residence of Tr.A.Balaji. Regarding this allegation, an enquiry was conducted. In this enquiry, the period from 01.06.2020 to 31.01.2022 was taken as a check period, taking into consideration of the entire service period. The enquiry revealed the following facts.

As on 01.06.2020, (i.e.) at the beginning of the check period, the accused was in possession of movable and immovable assets viz., (1) House in Door No.28/27, Kzhanikaattu Street, Shenbakkam, Vellore Taluk which was constructed before the Check Period in S.No.18 of Shenbakkam, Vellore Taluk (Govt. Poramboke land in the name of Tmt.Bakkiam Arumugam as per BMP No.3514). (2) 6 ³/₄ Sovereign of Gold jewels belongs to Tmt.Bakkiam (purchased by her husband), (3) 11 ³/₄ Sovereign of Gold jewels (purchased from the settlement amount received after the death of his father), (4) Honda Activa Motor Cycle TN-23-CB-9100, (5) Cash balance of Rs.194.31 in his SB A/c Nc. 32629763542 in SBI, Vellore Branch, Vellore District, (6) Cash balance of Rs.11,03,227.30 in SB A/c No.36738763978 heid in the name of Tmt.A.Bakkiyam (Mother of Tr.Balaji), in SBI, Vellore Branch.

As on 31.01.2022, (i.e.) at the end of the check period, cash of Rs.23,04,650/was found in the residence of the accused and an increase of cash balance of about Rs.1,12,600/- was also found in bank accounts of the accused and his mother in addition to the properties possessed by him as on 01.06.2020.

The accused and his mother had derived about Rs.13,86,850/- as their income by means of salary, pension, chit amount and of SB account interest during the check period, and they had incurred expenditure of about Rs.2,76,300/- towards the maintenance of family, payment of chit amount etc., during the check period Thus, his likely savings during the check period could be about Rs.11,10,550/-.

Thus, the accused appears to have been found in possession of properties and pecuniary resources disproportionate to his known sources of income to the extent of about Rs.13,06,700/-.

The above information discloses an offence of Criminal misconduct by Public Servant punishable u/s 13(2) r/w 13(1)(b) of the Prevention of Corruption Act, 1988 (as amended in 2018 by Act 16 of 2018) against the accused, and requires a detailed investigation.

Therefore, I am registering a case in Tirupathur Vigilance and Anti-Corruption Crime No.1/2025 u/s 13(2) r/w 13(1)(b) of the Prevention of Corruption Act, 1988 (as amended in 2018 by Act 16 of 2018) at 15.30 hrs today (23.01.2025) against the aforesaid accused for a thcrough investigation.

The original FIR is submitted to the Hon'ble Chief Judicial Magistrate cum Special Judge, Tirupathur and the copies are sent to the officers concerned.
