Based on a Vigilance Report submitted by an officer of the DVAC, a Preliminary Enquiry in PE 9/2024/COOP/TRP against Tr.D.Dharmendhiran, S/o Dravidaselvan, Co-operative Sub Registrar (PDS) of Kandhili Block, Tirupathur District was conducted into the allegation of possession pecuniary resources or property disproportionate to his known sources of income and the enquiry revealed the following facts: A-1 Tr. D. Dharmendhiran is working as Co-Operative Sub-Registrar (PDS) of Kandhili Block, Tirupathur District. On 28.04.1998, he joined the Co-Operative Department as a junior assistant/typist on compassionate grounds at the office of the Joint Registrar of Co-Operatives, Chennai Zone, and worked till 14.08.2000.

2. During the commission of the offence from 01.04.2010 to 31.05.2017, he got promoted as Junior Inspector and was transferred to the office of the Deputy Registrar (Non Credit), Chennai, and worked till 14.07.2010. On 15.07.2010 he was transferred to the office of the Deputy Registrar of Co-Operatives, Krishnagiri Range, and worked till 16.08.2012. On 17.08.2012 he was promoted as Senior Inspector and was transferred to the office of the Deputy Registrar of Co-Operatives, Tirupathur Range, and worked till 31.10.2016. He was promoted as Co-Operative Sub-Registrar/Field Officer, Natrampalli Block, and transferred to the office of the Deputy Registrar of Co-operatives, Tirupathur Range, and worked from 01.11.2016 to 31.12.2018. At present he is working as Co-Operative Sub-Registrar (PDS), Kandhili Block, Tirupathur District.

- 3. A-1 Tr.D.Dharmendhiran S/o Dravidaselvan, Co-Operative Sub-Registrar (PDS), Kandhili Block, Tirupathur District is a Public Servant as defined u/s 2(c) of the Prevention of Corruption Act, 1988 during the period of commission of offence.
- 4. Collection of sources reveals that the Accused Officer-1, Tr.D.Dharmendhiran, hails from a middle-class family. He is a native of Naidu Vattam, Periyakunichi Village, Tirupathur Taluk, Tirupathur District. His wife Accused-2 Tmt. R. Menaga W/o Dharmendhiran is a housewife and a native of Aravamattrapalli Village, Lakkinayakkampatti Post, Tirupathur Taluk, Tirupathur District. She also hails from a middle-class family, and they are gifted with two children.
- 5. It is gathered that the Accused-1, Tr.D.Dharmendhiran, has been found in possession of assets and pecuniary resources in his name and in the name of his wife, Accused-2 Tmt.R.Menaga, and enriched himself illicitly during the period of his office in various places. Most of the acquisition activities of Accused-1 Tr.D.Dharmendhiran and Accused-2 Tmt.R.Menaga fall between 01.04.2010 and 31.05.2017, and hence it was chosen as a tentative check period, and the Accused-1 Tr.D.Dharmendhiran and Accused-2 Tmt.R.Menaga W/o Dharmendhiran were found in possession of assets as detailed below.

- 6. The available information makes out a prima facie case against Accused-1 Tr.D.Dharmendhiran and his wife Accused-2 Tmt.R.Menaga W/o Dharmendhiran that they were in possession of pecuniary resources and properties to the tune of Rs.48,64,679/- during the check period, which is disproportionate to the known sources of their income, and the percentage of disproportionate assets worked out to 206%. Thereby the Accused-1 Tr.D.Dharmendhiran S/o Dravidaselvan committed the offences of criminal misconduct by intentionally enriching himself illicitly during the period of his office, and Accused-2 Tmt.R.Menaga W/o Dharmendhiran abetted him to commit the offence by acquiring the assets through the resources of Accused-1 Tr.D.Dharmendhiran.
- 7. Therefore today 28.01.2025 at 14.00 hrs, I register a case in Tirupathur Vigilance and Anti-Corruption Cr.No.02/2025 against Accused-1 Tr.D.Dharmendhiran S/o Dravidaselvan and his wife Accused-2 Tmt.R.Menaga W/o Dharmendhiran for commission of offence under section 13(2) r/w 13(1)(e) of the Prevention of Corruption Act, 1988 and under section 109 IPC r/w 13(2) r/w 13(1)(e) of the Prevention of Corruption Act, 1988.

The original First Information Report is submitted to the Hon'ble Chief Judicial Magistrate and Special Judge, Tirupathur, and a copy of the First Information Report is sent to the Superintendent of Police, Vigilance and Anti-Corruption, North Range, for issuing an order u/s 17 of the Prevention of Corruption Act, 1988, to investigate the case and authorization u/s 18 of the said Act to inspect bankers books in relation to the accounts of Accused-1 Tr.D.Dharmendhiran and his wife, Accused-2 Tmt.R.Menaga W/o Dharmendhiran.
