The following information was gathered during the collection of information against the Accused noted in the margin.

A-1 Mr.M.Anandan entered into the government service on 16.06.1993 as Gr.II Police Constable in Tamil Nadu Special Police at Avadi II Battalion. He had served as Gr.I Police Constable (SB) in Arani Town Police Station from 19.05.2008 to 30.06.2011, as Head Constable (SB) from 2011 to 2015, as Head Constable (SB) in Santhavasal Police Station from 22.06.2015 to 2016 and as Special Sub-Inspector of Police (SB) in Peranamallur Police Station from 2016 to 2020.

Accused -2 Mrs.A.Nathiya is the wife of the AO-1 Mr.M.Anandan and their marriage was solemnized on 07.02.2003. Mrs.A.Nathiya hailed from a middle-class family and she was a homemaker.

Accused-3 Mrs.P.Loganayaki is the mother in law of AO-1 Mr.M.Anandan. Mrs. Loganayaki was also a home maker but she was getting family pension due to the demise of her husband who was serving in Indian Army.

A-1 Mr.M.Anandan had served as Gr.I Police Constable (SB) in Arani Town Police Station from 19.05.2008 to 30.06.2011, as Head Constable (SB) from 2011 to 2015, as Head Constable (SB) in Santhavasal Police Station from 22.06.2015 to 2016 is public servant as defined u/s 2(c) of the Prevention of Corruption Act 1988 during the period of commission of offence.

Collection of sources reveals that the Accused Officer-1 Mr.M.Anandan, Accused Officer-2 Mrs.A.Nathiya and Accused Officer-3 Mrs.P.Loganayaki hail from a middle class family and they reside at Rattinamangalam village, Arani Taluk, Thiruvannamalai District.

It is gathered that the Accused-1 Mr.M.Anandan intentionally enriches himself illicitly, in the names of his wife Mrs.A.Nathiya and Mother-in-law Mrs.P.Loganayaki during the period of his office in various places. Most of the acquisitive activities of Accused-1 Mr.M.Anandan intentionally enriches himself illicitly, in the names of his wife Mrs.A.Nathiya and Mother-in-law Mrs.P.Loganayaki falls between 01.01.2010 and 31.12.2015 and hence it was chosen as tentative check period and the Accused-1 Mr.M.Anandan intentionally enriches himself illicitly, in the names of his wife Mrs.A.Nathiya and Mother-in-law Mrs.P.Loganayaki falls between 01.01.2010 and 31.12.2015 and hence it was chosen as tentative check period and the Accused-1 Mr.M.Anandan intentionally enriches himself illicitly, in the names of his wife Mrs.A.Nathiya and Mother-in-law Mrs.P.Loganayaki and found in possession of assets as detailed below.

The available information makes out a prima facie case against Accused-1 Mr.M.Anandan, A-2 Mrs.A.Nathiya and A-3 Mother-in-law Mrs.P.Loganayaki that they were in possession of pecuniary resources and properties to the tune of Rs.40,85,009/during the check period which is disproportionate to the known sources of income and the percentage of Disproportionate assets worked out to 133.58%, There by the A-1 Mr.M.Anandan, A-2 Mrs.A.Nathiya and A-3 Mother-in-law Mrs.P.Loganayaki had committed the offences of Criminal Misconduct by intentionally enriching themselves illicitly during the period of his office and his wife Accused-2 Mrs.A.Nathiya and motherin-law Mrs.P.Loganayaki had abetted him to commit the offence by acquiring the assets through the resources of Accused-1 Mr.M.Anandan.

Hence, there is prima facie materials available on record for taking up the investigation against the Accused-1 Mr.M.Anandan, commission of offences u/s 13(2) r/w 13(1)(e) of Prevention of Corruption Act 1988 and against A-2 Mrs.A.Nathiya and A-3 Mother-in-law Mrs.P.Loganayaki for commission of offences u/s 13(2) r/w 13(1)(e) of Prevention of Corruption Act 1988 and under section 109 IPC.

Therefore today 28.01.2025 at 18.00hrs, I registered a case in Thiruvannamalai Vigilance and Anti-Corruption Cr.No.04/2025 against Accused-1 Mr.M.Anandan, commission of offences u/s 13(2) r/w 13(1)(e) of Prevention of Corruption Act 1988 and against A-2 Mrs.A.Nathiya and A-3 Mother-in-law Mrs.P.Loganayaki for commission of offences u/s 13(2) r/w 13(1)(e) of Prevention of Corruption Act 1988 and under section 109 IPC.

The Original FIR is submitted to the Hon'ble Chief Judicial Magistrate cum Special Judge, Tiruvannamalai and copies were sent to the Officers concerned.
